Call to Order

Program Evaluation & Development (PE&D) Committee

Tony Hallman reported that the Program Evaluation & Development Committee met the previous week on May 17 to review the programs that will be on the agenda for approval for Formula funding.

Conflict of Interest Forms

Alexis Matthews checked with board members to ensure conflict of interest forms were completed before voting on recommendations for Formula funding.

Overview of Formula Funding

Alexis Matthews provided an overview of the AmeriCorps Program funding awarded for 2022-2023 AmeriCorps programs through the Competitive and Public Health AmeriCorps Application and an overview of the Formula Application process. She stated that thirteen of the fifteen Competitive applications submitted to AmeriCorps were approved for just over \$5.2 million in funding. Five additional programs were approved for over \$4.6 million in Public Health AmeriCorps funding, four of which are currently funded programs in our portfolio. The fifth is the Wisconsin Association of Free and Charitable Clinics, which currently has AmeriCorps VISTA members. She stated that we received our formula allocation amount, just over \$2.89 million, following the PE&D meeting.

2022-2023 AmeriCorps Formula Cost-Reimbursement Applications

Alexis indicated that NCCAP AmeriCorps and Wisconsin DPI – Farm to School were previously recommended by the board for Competitive funding but were not funded by AmeriCorps, so they are recommended for Formula funding. Alexis described the applications received during the Formula process and explained that following peer review and staff review, in addition to continuation programs, one new AmeriCorps program, Green Bay Conservation Corps, and seven planning grants were being recommended for funding.

She also described working with one of the UW System Regents, an AmeriCorps alumnus, to discuss potential matching for the Segal Education Award.
