Call to Order

The meeting was called to order at 12:30 pm by Board Chair Paula Horning.

<u>Introductions</u>

The commission members and Serve Wisconsin staff introduced themselves.

Public Comment

A recorded video welcome message from College Possible Executive Director Edie Turnbull was played.

Steve Frodl, AmeriCorps Program Director for North Central Community Action Program, shared information about three NCCAP AmeriCorps members who were awarded the Herb Kohl Helping Hand award during the Poverty Matters Summit – Statewide Edition on September 27, 2018; the members received the award for creating the "Blue Bin Project," which provides a bin filled with small, colorful bags of assorted, child-friendly trinkets, personal hygiene products, and an age-appropriate book that is offered to children of low income families who come into the NCCAP Wausau office seeking housing assistance.

Meeting Minutes

James Langdon made a motion to approve the June 7, 2018, WNCSB meeting minutes. Second by Robert Griffith. Unanimously approved.

Memorandum of Agreement between Illinois & Wisconsin

The Board resumed discussion on this matter tabled from the June 7, 2018, Board meeting. Jeanne Duffy provided additional information on the Memorandum of Agreement that the Illinois State Commission Executive Director has asked Serve Wisconsin to sign. Christine Beatty made a motion to approve Serve Wisconsin's signing of the agreement with the Illinois State Commission. Second by Kate

Jaeger. Unanimously approved. Board members expressed interest in receiving an annual report on activities engaged in under terms of the agreement.

2019-2021 State Service Plan

Jeanne Duffy provided an update on activities of the Board's State Service Plan Committee, including results of the Community Input Survey. The draft 2019-2021 State Service Plan was presented for Board consideration/approval. Christine Beatty made a motion to approve the 2019-2021 State Service Plan. Second by Robert Griffith. Unanimously approved.

Commission Support Grant Permission to Submit

As has been the case each year, CNCS issues their Commission Support Grant NOFO and corresponding application submission deadline between the Board's regular October and December meetings. James Langdon made a motion to approve permission for staff to submit the Commission Support Grant application. Second by Christine Beatty. Unanimously passed. Board members will receive copies of Commission Support Grant application documents along with other documents for the Board's December meeting.

2019-2021 State Service Plan – Additional Discussion

Paula Horning had further concluding remarks regarding the State Service Plan. She stated that the Board would be interested in setting targets for elements of the State Service Plan, and having results toward targets reviewed annually by the Board.

CNCS Wisconsin State Office Director Sarah Brady provided updates on the following:

Updates from Commission Members

Kate Jaeger reported that 16th Street Community Health Center staff attended Serve Wisconsin's grant writing workshop and the organization is thinking about applying for its own program. In the past the organization has had AmeriCorps members serve through a National Direct program, through Wisconsin's Health Corps and Farm to School AmeriCorps programs, and has had AmeriCorps VISTA members.

James Langdon reported that he had received an inquiry from a Board member regarding the performance evaluation for the Serve Wisconsin Executive Director. He stated that he prepares a draft of the performance evaluation, including entering information for any evaluation elements that are covered by his areas of responsibility; the draft then goes to Board Chair Paula Horning for completion/finalization. He also stated the he takes his cues from the Board Chair on any performance issues. He also noted that personnel policies restrict access to employee performance evaluation information.

Christine Beatty provided an update on her ASC States for Service leadership activities; her attendance at the CNCS Symposium and Hill Day held in September; and noted the CNCS success of receiving additional funds for AmeriCorps and Senior Corps in the recently approved federal budget and appropriations.

Casey Sweeney provided update information regarding the RFP process for 2019-2020 AmeriCorps funding.

Kara Rivers provided an update on the supplemental Commission Investment Fund grant funding Serve Wisconsin received for disaster response/recovery; the supplemental funding will be used for training of Serve Wisconsin and AmeriCorps program staff, and for quick response kits that will include supplies for use by AmeriCorps members who respond to disasters
