Serve Wisconsin Among Eight States Selected to Receive Afterschool Grants from ASC, Mott Foundation

New program development initiative will expand afterschool opportunities through AmeriCorps in Wisconsin



MADISON, WI — Wisconsin will be better poised to expand out-of-school time opportunities for youth at a statewide level, thanks to new funding that has been awarded to Serve Wisconsin from the Charles Stewart Mott Foundation in partnership with America's Service Commissions (ASC).

The Mott Foundation awarded a \$250,000 grant to ASC in September for a multi-year initiative to identify how the state service commission network can expand afterschool opportunities through national service, such as AmeriCorps.



As part of the initiative, ASC has selected eight state service commissions, including Serve Wisconsin, to receive \$12,500 mini-grants. Funding will support staff and consultant time to develop a better understanding of the local afterschool landscape and identify potential paths for developing national service programming that will expand the quality and quantity of afterschool opportunities in their respective states.

In addition to Wisconsin, the following states were selected to receive this funding include:

Idaho: <u>Serve Idaho</u>
Indiana: <u>Serve Indiana</u>
Iowa: Volunteer Iowa

Kansas: <u>Kansas Volunteer Commission</u>

Maine: Maine Commission for Community Service

Rhode Island: <u>Serve Rhode Island</u>West Virginia: <u>Volunteer West Virginia</u>

In Wisconsin, the funding will allow Serve Wisconsin to work with the Wisconsin Afterschool Network to enhance and expand the impact of AmeriCorps placements and national service resources by conducting an asset mapping project that will support the creation of an afterschool programing/out-of-school time (ASP/OST) data warehouse and dashboard effort that will:

- Identify gaps in afterschool programs that Serve Wisconsin will help fill by working with community organizations
- Further investigate and generate new definitions of quality afterschool programming by engaging new communities and stakeholders, especially those from traditionally underrepresented communities to help afterschool programs provide quality programing
- Determine those programs most in need of additional support and the type of support needed
- Lead to statewide policies that secure resources that will sustain new and existing afterschool programs
- Identify how service learning is being used in after school programing and how it can be used

These outcomes will further align effective AmeriCorps recruitment and placement by:

- Better detailing the responsibilities of each staff member to deliver quality ASP/OST programing
- Clarifying procedures and documentation needed for new member applications, placements, interviews, and offers to create maximum impact matches
- Specifying the responsibilities of the umbrella organization, individual programs, and sponsors
- Identifying areas that lack after-school programing that would be suitable AmeriCorps sites

Serve Wisconsin will also receive support from America's Service Commissions, through monthly learning community calls, ongoing coaching, and a yearly convening for the states receiving grants.

"We are honored to have been selected for this important afterschool initiative," said Jeanne Duffy, Serve Wisconsin's Executive Director. "With ASC's support and Mott Foundation's strong connections to afterschool networks, we are confident that we can make a real difference for a lot of young people in Wisconsin through AmeriCorps and national service programming."

"We are excited to partner with Serve Wisconsin on this effort, and to help support the future expansion of afterschool opportunities and AmeriCorps programming in Wisconsin," said ASC CEO Kaira Esgate.

In addition to supporting states, ASC will work with the National Network of Statewide Afterschool Networks and other key stakeholders to develop new strategies around afterschool program development over the next two years.

Through this effort, ASC believes that the project will lead to an increased understanding between state service commissions and statewide afterschool networks about how to leverage national service and AmeriCorps resources in support of high-quality afterschool opportunities nationwide.
